

# IF THE BROKER ACTS AS AN INTERMEDIARY:

A broker may act as an intermediary between the parties if the broker complies with The Texas Real Estate License

The broker must obtain the written consent of each conspicuous bold or underlined print, set forth the broker's obligations as an intermediary. The broker is required to honestly and fairly and to comply with A broker who acts The Texas Real Estate License Act. as an intermediary in a transaction: treat each party

- (1) shall treat all parties honestly;
- (2) may not disclose that the owner will accept a price less than the asking price unless authorized in writing to do so by the owner;
  - may not disclose that the buyer will pay a price greater than the price submitted in a written offer unless authorized in writing to do so by the buyer; and may not disclose any confidential information or (3)
- any information that a party specifically instructs the broker in writing not to disclose unless authorized in writing to disclose the information or required to do so by The Texas Real Estate License Act or a court order or if the information materially relates to the condition of the property. 4
